

## RHT Legal Training Institute: Part A Bar Course FAQs

### 1. Who should attend the Part A Bar Course?

The Part A Bar Course is designed to familiarize graduates of Overseas Scheduled Universities with Singapore law.

Candidates should ensure that they are registered for the Part A Exam with SILE. RHTLTI cannot do this. There can be no refunds if for any reason whatsoever a candidate is unable to register or sit for the Exam.

### 2. How much is the Part A Bar Course Fee?

#### First-time taker of the Exam

- Fees for entire programme (all five Part A subjects): S\$3,000

#### Re-taker of the Exam

- Fees for 3 subjects of Part A: S\$2,400
- Fees for 2 subjects of Part A: S\$1,800
- Fees for 1 subject of Part A: S\$1,200

*\*We require candidates to send us proof that they previously took the Bar exam.*

### 3. Can I apply to sit for the Part A Bar Course if I have not graduated yet?

Yes, you can register for the Part A Bar Course if you are graduating soon from your law degree. Please note that RHT Training Institute do not process your application for SILE Part A Bar Examination. ### 4. What are the subjects to be covered for the course?

There will be eight three-hour sessions for each of the five subjects, viz, Company Law, Criminal Law, Land Law, Evidence Law and Singapore Legal System. Details of the subjects are to be found at <https://www.sile.edu.sg/examinable-subjects>.

### 5. How long is the course duration?

The Part A Bar Exam Course session 2 will commence on 8 August 2022, and last for eight (8) weeks. There will be one three (3) hour session per day, each session covering one of the five prescribed subjects (15 hours a week).

### 6. What is the course mode of instruction?

The Part A Bar Course is online.

### 7. Who are the instructors?

The course will be taught by experienced legal professionals.

- Company Law – By Professor Walter Woon S.C.
- Criminal Law - By Professor Walter Woon S.C.
- Singapore Legal System – By Dr. Kevin Tan
- Land Law – By Mr Avin Chen

- Evidence Law – By Mr Alex Woon

#### **8. How should I join the online class?**

Candidates will be issued login information to RHT Learning Management System for the online class. They are to further observe and abide by the non-sharing clause during their online classroom sessions. Access to the online Teaching Sessions must not be made available to any person other than the candidate.

#### **9. Do I need to turn my video camera on during the class?**

Yes, candidates are required to turn their video camera on during the online class.

#### **10. Does RHT Legal Training Institute provide notes or materials for the course?**

No, we don't provide notes for the course. The RHTLTI Course will be conducted in accordance with the SILE reading lists, though these may be re-organized or supplemented where appropriate.

Similarly, candidates who register for Part A of the Bar Examination will be provided by SILE with access to cases and other materials. Accordingly, RHTLTI will not duplicate this and candidates should make use of whatever materials SILE provides.

#### **11. If I miss a class/ session, will there be a makeup class?**

No, there will be no make-up classes for candidates who miss classes/sessions.

#### **12. Is the course recorded?**

Yes, the course is recorded but it will not be made available to candidates. It is for internal and CPE compliance purposes only. It will not be available for anyone who misses a class/session.

#### **13. Can I get a refund, in the event I withdraw for the class?**
